Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt. Do not re-use empty containers. Use only in well-ventilated areas. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.
